TO: Landowners living in Ravalli, Mineral and Missoula Counties Wildland-Urban Interface and other interested parties

## **RE: Private Landowner Hazardous Fuels Treatment Grant Cost-Share Application**

Enclosed is an application form for the above-referenced program. Grant funding may be available to assist private landowners and communities living in the Wildland-Urban Interface within Ravalli, Mineral and Missoula Counties as follows:

1. Assist private landowners and communities reduce the fire risk by thinning and cleaning up hazardous fuels on their property while improving forest health on private lands.
2. Help landowners create and maintain defensible space within the Home Ignition Zone around their homes from the threat of wildland fire.

Applications from individual landowners, groups of homeowners, and communities are being solicited. All project proposals will be considered; however, the following criteria will be followed in prioritizing project proposals for funding:

1. Proximity to National Forest land & the Wildland-Urban Interface boundary.
2. Location of property(ies) relative to the High Risk areas (high threat of damage from wildfire – high fire behavior potential) delineated on the current Community Wildfire Protection Plan fire risk/WUI maps and the State of Montana Forest Action Plan.
3. Projects proposed by multiple landowners and/or communities.
4. Projects to protect Municipal watershed values.
5. Projects to protect high values at risk such as, structures, historic sites, old growth areas, riparian/wetland areas, powerline corridors, electronic sites, and other values at risk from wildfire.
6. Cooperative projects that are critical fire control points to protect more than one landowner and create enhancement of access for fire protection and evacuation.
7. Landowners who have previously demonstrated a commitment to reducing fuel hazards.
8. Areas that demonstrate good, solid community support for reducing fuel hazards in areas where hazardous fuel treatment has not taken place.
9. Areas with forest health problems that will contribute to increased threat of wildfire to areas needing protection of identified values at risk indicated above.

Hazardous fuels reduction projects will be cost-shared on a 50:50 matching basis in Missoula and Ravalli Counties. In-kind services performed by the landowner will be considered in the cost-share calculation. Projects in Mineral County will be 75:25 cost share if the landowner hires a contractor to perform the work. This means the grant will pay for 75% of the contractor costs. If the landowner in Mineral County elects to do the work themselves on their own property, then the cost share will 50:50.

The purpose of this funding is to (1) reduce the fire risk around structures within the Home Ignition Zone, (2) reduce the fire risk by decreasing the chances of a stand replacement crown fire moving through forested areas, and (3) decrease the ladder fuels, thus decreasing the chances of a fire burning on the ground from entering the crowns of the standing trees and becoming a major fire. Specifications for treatment are to reduce the crown

density by thinning trees to an average of 10 feet between crowns; pruning lower branches up to 10 feet or 1/3<sup>rd</sup> the height of the tree, whichever is less; and treating all slash created by thinning and pruning as well as any existing fuel concentrations. These requirements may vary given the timber type, access, slope, aspect and other on-the-ground variables. The project inspection provided by RC&D foresters will also address the susceptibility of your home to wildfire intrusion and give landowners specific recommendations on how to mitigate the risk to homes and other structures.

Grant application forms are available at the Bitter Root RC&D office in Hamilton. An application form can also be obtained from the Bitter Root RC&D website at [www.bitterrootrcd.org](http://www.bitterrootrcd.org).

Applications will be accepted yearlong for cost-share funding and will be kept on file for future reference and grant opportunities.
